The mission of the Florida Board of Professional Engineers (FBPE) is to protect the interest of public health and safety by properly regulating the practice of engineering. The FBPE also desires to serve its licensees by establishing and maintaining relationships with its licensees' engineering associations and societies. For that reason, the FBPE requests the assistance of the American Society of Plumbing Engineers - West Coast Florida Chapter in order to better serve its licensees.

Specifically, the FBPE desires to establish a relationship with your organization and in doing so provide your members with an opportunity to participate in FBPE committees and rule making matters. In addition, your organization will be able to bring industry issues and concerns directly to the attention of the FBPE.

To establish our relationship, the FBPE requests that American Society of Plumbing Engineers - West Coast Florida Chapter provide some basic information such as current contact information for its officers, executive director and liaison to the FBPE. With this information your organization will receive regular FBPE business meeting notices as well as opportunities for your members to participate as representative in select committees.

In addition, the FBPE is asking that American Society of Plumbing Engineers - West Coast Florida Chapter provide a liaison to participate in FBPE meetings. By providing a liaison, your organization will be able to assist in the dissemination of statute and rule updates, activities of the FBPE and its various committees, activities of the Florida Engineers Management Corporation (FEMC), and activities of the National Council of Examiners for Engineers and Surveyors (NCEES).

In return, the FBPE will:

- Add American Society of Plumbing Engineers - West Coast Florida Chapter to the published list of engineering associations and societies with which FBPE maintains relationships;
- Provide a link for American Society of Plumbing Engineers - West Coast Florida Chapter on the FBPE website. FBPE also requests that American Society of Plumbing Engineers - West Coast Florida Chapter provide a link on its website to the FBPE website;
- Make the FBPE Chair, Vice-Chair and select staff members available for presentations to American Society of Plumbing Engineers - West Coast Florida Chapter regarding Florida engineering laws & rules or on FBPE and NCEES activities;
- Invite American Society of Plumbing Engineers - West Coast Florida Chapter to submit articles as outlined in FBPE's *Style Guide & Information for Outside Authors* for consideration and possible publication on the FBPE's website; and
- Invite American Society of Plumbing Engineers - West Coast Florida Chapter to submit event announcements and activities or recent accomplishments for consideration and possible publication on FBPE's website or for posting on FBPE's social media outlets (Facebook, LinkedIn, etc.).


On behalf of the Florida Board of Professional Engineers, we look forward to your consideration of the above proposal and hope to hear from you soon.
